Deloitte response to the request for comments on the Exposure Draft: Proposed South African Auditing Practice Statement (SAAPS) 3 (Revised), *Illustrative Reports* (proposed SAAPS 3 (Revised).

We thank you for the opportunity to provide comments in response to the proposed proposed SAAPS 3 (Revised) issued by the Independent Regulatory Board for Auditors ("IRBA") on 21 September 2023.

Deloitte supports the proposed SAAPS 3 (Revised) after considering the clarity, understandability and practical application of proposed SAAPS 3 (Revised).

However, we have one suggestion which relate to Question 1 of the explanatory memorandum:

Question 1: Do you agree with the proposed amendments to illustrative report 1 and illustrative report 3 in Part A?

Deloitte response: Illustrative report 1 refers to "in terms of the IRBA rule on Enhances Auditor Reporting" multiple times. Our suggestion is that instead of referring to the Enhances Auditor Reporting multiple times to only include an additional section under the "Report on Other Legal and Regulatory Requirements" section of the audit report, as follows: This report has been prepared in terms of the IRBA Rule on Enhanced Auditor Reporting for the Audit of Financial Statements of Public Interest Entities, published in Government Gazette Number 49309 dated 15 September 2023 (EAR Rule).
